- RE: Concordia University Texas Governance

On Friday, February 10, the Concordia University Texas Board of Regents met to consider a request from the LCMS to return to the previous governance structure directed by The Lutheran Church – Missouri Synod (LCMS). After much deliberation, the Board passed a resolution that, while continuing its strong desire to be a part of Synod, it shall seek more information and counsel from the LCMS Board of Directors before being able to consider Synod's request fully, which means the University's Board remains the sole governing body of the institution.

Earlier in January, our Board met with representatives from the Concordia University System and the LCMS to hear their concerns and discuss any possible actions moving forward. Friday's request for further conversation reflects the Board's commitment to ongoing dialogue and finding the best way forward for the University and the students and communities it serves.

We remain devoted to our alignment with the Synod and our history of providing Lutheran higher education. In many ways, we are strengthening this commitment and our calling to be a part of the mission of the church at large. The Board has adopted guiding principles for the University that formalize the demonstration of our LCMS identity. These principles state the following:

- Subscription to the Confession of the LCMS as currently outlined in Article II of the LCMS Constitution.
- All Board members will be active members of LCMS congregations,
- The Board will reserve two seats for representation from the LCMS and the Texas District of the LCMS.
- The Board will conduct an annual review and assessment of the institution's Lutheran identity.
- All called workers will continue to be under the ecclesiastical supervision of the Texas District President.

Regarding the Board's decision of November 8, it is essential to know that they did not come to this governance decision hastily. For over a year, the Board had engaged in deep analysis, deliberate conversations, and steadfast prayer about the University's governance structure. These intentional discussions centered on ensuring Concordia University Texas can continue fulfilling its mission to provide students of all backgrounds with high-quality, Christ-centered higher education that prepares them for meaningful work.
