According to the Department of Education, we must request documentation supporting the information listed on your FAFSA.

Please Note:

- 1. If there is more than one parent listed on the FAFSA and a joint tax return was not filed, IRS Data Retrieval may not be used. Both parents must submit a copy of their IRS Tax Return Transcript.
- 2. If either parent filed, or will file, an amended 2017 IRS Tax Return, an IRS Record of Account must be requested instead of an IRS Tax Return Transcript.

□ IRS Data Retrieval (your parent(s) should follow the steps below) - Date Completed:

- 1. Log onto the FAFSA website (http://www.fafsa.ed.gov) and click the "Make Corrections" link.
- 2. Go to the Financial Information portion of the FAFSA.
- 3. Enter your FSA ID and click "Link to the IRS."
- 4. The FAFSA will be saved and you will be transferred to the IRS website.
- 5. On the IRS website, enter the requested information.
- 6. Once the IRS has validated your identification, your IRS tax information will display. You can either transfer your information from the IRS, or choose to return to FAFSA on the Web from the IRS website. If you do not transfer your information or choose not to return from the IRS website, you will have to login to open the saved FAFSA. If you transfer your IRS tax information, questions that are populated with tax information will be marked with "Transferred from the IRS."

□ **IRS Tax Return Transcript** (do not submit form without transcript attached & Banner ID written on the transcript) Your parent(s) should choose one of the following methods to request an IRS Tax Return Transcript:

- **Online:** Go to www.irs.gov, select "Get Your Tax Record" and request the "IRS Tax <u>Return</u> Transcript." Transcripts are available in real-time in PDF format which can be printed and submitted as a hard copy or submitted electronically to Student Financial Services.
- **Phone:** Call 1.800.908.9946 to submit your request using an IRS automated process. Allow 5-10 business days after request is submitted.
- Mail: Submit IRS Form 4506T (available from IRS website). Allow 30 calendar days from the time the IRS receives the request.
- **Mobile App:** Download **IRS2Go** mobile app available from iTunes and Android Marketplace. Use the "Tax Records" to submit transcript request. Allow several business days after submitted. *A copy of your tax return is not acceptable documentation for Federal Student Aid.*
