To move forward with processing your 2627 FAFSA and finalizing your 2627 Financial Aid package, our office must verify your identity. According to the U.S. Department of Education regulations, you must complete one of the following options:

Option 1: You may appear in person and present acceptable identification to a Concordia University Texas (CTX) faculty or staff member to be copied, dated, and signed by the approved CTX faculty/staff member. For this purpose, "acceptable identification" refers to a valid unexpired government-issued photo ID, which is one that is issued by the U.S. government, any of the 50 states, the District of Columbia, Puerto Rico, a federally recognized American Indian and Alaska Native Tribe, American Samoa, Guam, the Virgin Islands, the Commonwealth of the Northern Mariana Islands, the Republic of the Marshall Islands, the Federal States of Micronesia, or the Republic of Palau. For a list of acceptable and unacceptable documents, please refer to the next page.

Option 2: You may be verified by an entity that is compliant with the National Institute of Standards and Technology Identity Assurance Level 2 (NIST IAL2). To satisfy your verification requirement with the school, CTX must receive documentation directly from the entity confirming that your identity was verified under the NIST IAL2 standard and the date of the verification.

If CTX determines that you are unable to appear in person, you may:

- 1) provide CTX with a copy of a valid government-issued photo identification and the Notary's Certificate of Acknowledgement (see third page) witnessing you have presented acceptable identification. Once the Notary's Certificate of Acknowledgement is complete, send the original document to Student Financial Services at the address below, OR
2) Appear on a video call with a designated CTX faculty or staff member and present the acceptable identification to them. If this option is used, you must also provide the CTX faculty or staff member with a copy of your identification document to be signed and dated by them.

VERIFICATION OF IDENTITY 2026-2027

Please see the information below for examples of acceptable and unacceptable documentation for purposes of Title IV verification.

Acceptable Documents: A valid, unexpired U.S. government-issued photo identification (photo ID) can include, **but is not limited to**, the following:

- U.S. Passport (book or card)
- Driver's license
- Non-driver's identification card
- Other state-issued ID
- Global Entry Card
- Permanent Resident Card or Resident Alien Card (I-551)
- Certificate of Naturalization if it contains a recognizable photo
- Inmate ID issued by a correctional facility, as long as they are still confined or incarcerated
- State-issued voter ID, even if it does not have an expiration date

Unacceptable Documents:

- Government-issued photo IDs from a foreign country
- Military IDs and Common Access Cards (due to the general prohibition on photocopying military IDs)
- Temporary Driver's Licenses
- Student IDs (not even those issued by state schools)
- Supplemental Nutrition Assistance Program IDs (SNAP IDs) with or without a picture as they should not be photocopied
