Standard Track (24 months)

- ▶ 36 Credit Hours
- ▶ Six semesters
- ▶ 8 week & 16 week courses
- ▶ Class one night per week
- ▶ Locked-in Tuition

OR

Fast Track (16 months)

- ▶ 36 Credit Hours
- ▶ Minimum cumulative undergraduate GPA of 3.5
- ▶ Nine credits per semester (online and on-ground)
- ▶ Graduate in four semesters
- ▶ Locked-in Tuition

Tuition & Fees

- ▶ \$710 per credit hour (locked tuition for continuously enrolled on-ground students)
- ▶ \$50 Professional Development fee (per semester)
- ▶ \$100 General Services fee (per semester)
- ▶ \$300 MBA Capstone fee (final semester only)
- ▶ \$150 per semester for books (when enrolled in Tornado Textbooks)

- \$4,260 Tuition (6 credit hours)
